Position Purpose

Position Responsibilities

- Manage the implementation of and maintain, Mental Health Australia's customer relationship management system (CRM), ensuring accurate recording of membership administration, development of best practice customer relations management processes and training of staff.
- Develop and implement structures and processes for capturing the priorities of members and stakeholders, and respond to members and stakeholders in a timely manner and with a strategic focus.

- Develop and implement Mental Health Australia's annual member survey, including analysis and reporting back to senior Mental Health Australia staff with recommendations on future engagement and policy activities.
- Conduct research and provide advice on sector trends, improving member value and identifying risks in accordance with Mental Health Australia's internal, sector-specific and public communications.
- Consult with members and other relevant stakeholders on a regular basis to identify key strategic issues and opportunities, ensuring these are communicated to Mental Health Australia staff and external stakeholders where appropriate.
- Develop and effectively manage relationships with Mental Health Australia World Mental Health Day campaign partners.
- Promote Mental Health Australia membership benefits and encourage members and stakeholders to be regularly involved in Mental Health Australia's activities.
- Provide input and advice to senior Mental Health Australia staff and Board members on areas of expertise, particularly around engaging stakeholders that are difficult to reach
- Write and edit material for publications, reports and other communications and campaigns, as required
- Work with the Director of External Relations to develop and implement Mental Health Australia's Communications Plan, with a specific Stakeholder Engagement that aligns with the organisation's Strategic Plan.

- Well-developed problem-solving skills, demonstrated creativity and an ability to deliver on ideas.
- Strong organisational and project management skills, including the ability to manage multiple projects simultaneously.
- Ability to work autonomously and in a small team environment.
- Able to demonstrate values consistent with Mental Health Australia.
